**Subject: Notification of Construction Work in terms of The Occupational Health and Safety Act 85 of 1993, Construction Regulations 2014, regulation 4.**

***Notification of construction work***

**4.** (1) *A contractor who intends to carry out any construction work other than work contemplated in regulation 3(1), must at least 7 days before that work is to be carried out notify the provincial director in writing in a form similar to Annexure 2 if the intended construction work will—*

- (a) *include excavation work;*
- (b) *include working at a height where there is risk of falling;*
- (c) *include the demolition of a structure; or*
- (d) *include the use of explosives to perform construction work.*


(2) *A contractor who intends to carry out construction work that involves construction of a single storey dwelling for a client who is going to reside in such dwelling upon completion, must at least 7 days before that work is to be carried out notify the provincial director in writing in a form similar to Annexure 2*

In order to comply with the above mentioned regulation, the Occupational Health and Safety Chief Directorate through the Construction Sub-Directorate hereby advice all contractors as follows:

- The annexure 2 (Notification of construction work) must be completed in full.
- If a similar form is used, therefore it must have all the required information as per the annexure 2.
- Both the contractor and the client **MUST** sign the annexure 2 before submission to the Department.
- The annexure 2 must be sent to a provincial office were construction work will be carried out. (See attached document of Provincial OHS specialist)
