Key findings

Table 1: Contract price adjustment provisions (CPAP) work group indices

Noteworthy month-on-month changes in April 2025 were as follows:

Work group 172 – refrigeration installations: the index increased by 1,5%, driven by the following changes:

- 3,1% in the SEIFSA index for metal price - copper - metric ton (table F) (accounting for 40,0% of this group);
- 0,4% in the index for electrical engineering (accounting for 10,0% of this group); and
- 1,8% in the SEIFSA index for equal angles (accounting for 5,0% of this group).

Work group 120 – waterproofing: the index increased by 1,0%. There was a change of 6,0% in the PPI index for adhesives and sealants (accounting for 16,0% of this group).

Work group 152 – painting: the index increased by 1,0%. There was a change of 2,0% in the index for paints (accounting for 35,0% of this group).

Work group 125 – metal roofing (aluminium): the index decreased by 2,4%. There was a change of -2,7% in the SEIFSA index for aluminium products 99.7 EC grade rod (accounting for 90,0% of this group).

Work group 171 – ductwork installations: the index decreased by 4,1%. There was a change of -9,1% in the SEIFSA index for galvanised sheets (table E-X) (accounting for 50,0% of this group).

Work group 124 – metal roofing (steel): the index decreased by 7,5%. There was a change of -9,1% in the SEIFSA index for galvanised sheets (table E-X) (accounting for 85,0% of this group).

Tables 2 and 3: Construction input price index (CPII)

The annual change in the total construction index was 1,5% in April 2025. The index increased by 0,3% month-on-month.

The following indices recorded noteworthy month-on-month changes:

- ready-mix concrete (5,2%);
- construction tyres (3,5%);
- paints (2,0%);
- construction pipes, tubes and fittings (1,5%);
- construction structural and reinforcing steel (-0,7%); and
- construction stone and sand (-1,6%).

Table 4: Mining and construction plant and equipment price indices

The annual change in the plant and equipment index was 9,6% in April 2025. The index increased by 0,1% month-on-month.

Table 5: Mechanical and electrical engineering input price indices

The annual change in the mechanical engineering index was 1,6% in April 2025. The index increased by 0,4% month-on-month. The annual change in the electrical engineering index was 8,8% in April 2025. The index increased by 0,4% month-on-month.

Table 6: Civil engineering material price indices

The annual change in the total index (civil engineering material) was 1,2% in April 2025. The index decreased by 0,9% month-on-month.

Glossary

Construction Input Price Indices (CIPI)	The index reflects material purchases in the construction industry.
Contract Price Adjustment Provisions (CPAP)	The CPAP work group indices are used for making adjustments based on cost fluctuations in labour, plant and materials.
Contract Price Adjustment Provisions Steering Committee	The committee is the oversight structure for the Construction Price Adjustment Provisions published by Statistics South Africa (Stats SA) and includes representatives from the following industry associations and organisations: The Association of South African Quantity Surveyors (ASAQS), Electrical Contractors' Association (SA), Master Builders South Africa, South African Institute of Architects, Department of Public Works and Stats SA.
CPAP manuals	The updated CPAP manuals "CPAP Application Manual" and "CPAP Work Groups Composition and Weighting of Sub-Indices" are obtainable from ASAQS' website: www.asaqs.co.za – search for CPAP, or by phoning (012) 406 3304.
Respondent response rate	The respondent response rate for April 2025 was 98,7%. The rate was calculated using the total number of companies where prices were collected as a percentage of the total sample.
Sources for CPAP	The CPAP work group indices are derived from changes in the cost structures prevailing in 38 different work activities of the building industry. They are published by Stats SA monthly. The indices reported on in this publication are mainly based on a combination of PPI, SEIFSA and CPI indices for the particular month.
Tax	Value-added tax (VAT) is not included in these indices.
Weights	Weights are updated according to the availability of new information, as follows: • Tables 1 and 6 are updated periodically in consultation with industry expert committees. • Tables 2, 3 and 5 are partially updated annually using Stats SA's supply and use tables, with effect from the January statistical release each year. • Table 4 is updated periodically using Stats SA's large sample survey for the manufacturing industry and SARS trade data. • Tables 2, 3, 4 and 5 are updated on a detailed level, using Stats SA's large sample surveys for the construction and manufacturing industries, approximately every three to four years.
Revised figures	The SEIFSA data is continuously updated and therefore Stats SA allows for revisions of the CPAP work group indices. Revisions will be promptly indicated in relevant tables to maintain transparency and accuracy.
