BCCEI National Negotiations 2025

The BCCEI stakeholders (NUM, BCAWU, CEO and SAFCEC) started 2025 negotiations on 2 April 2025. The SAFCEC team included Mike Sikhakhane, Ruth Maseko, Dazerene du Plessis and Malachi Molawa as main members, with Frangy Lelake, Geoff Kemper and Queen Magoro as observers.

After 4 rounds of negotiations, parties deadlocked but reached settlement on 4 August 2025, covering Wage & Task Grade and Conditions of Employment Agreements, valid until 31 August 2028.

Current agreements were extended for six months, until 28 February 2026 or promulgation date, whichever occurs first.

Industry News

Minister Dean Macpherson welcomed Q3 economic data showing 0.1% growth in construction after three consecutive quarters of decline. The Quarterly Labour Force Survey showed 130,000 jobs created in construction, nearly half of all S.A. jobs during this period.

This emergency recovery demonstrates that reform efforts across the public-infrastructure system are taking effect. Strengthened procurement oversight, decisive action on non-performing contractors, improved project preparation through ISA, and reduced construction-mafia work stoppages have restored confidence.



"This is not yet the finish line, but it is a clear indication that construction is moving in the right direction. Our task now is to consolidate this early momentum, accelerate reforms, and increase infrastructure investments to drive economic growth and job creation."

The South African Construction Action Plan (SACAP) reforms have laid the foundation for longer-term stability by introducing measures to professionalise the sector, strengthen governance, and improve accountability across the delivery chain.
